

# **Product description**

"Glavaflex",

is a flexible elastomeric foam based on synthetic rubber with adhesive. The product to be installed must be glued on site or can be offered as self-adhesive.

Total thickness: 32 mm

Total density: approx. 50 kg/m<sup>3</sup>

# **Application/Limitation**

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for all colour variations

Maximum organic content: approx. 45%

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Approved for use as decorative veneer on a metallic substrate with thickness of at least 1 mm.

The product satisfies the requirement for maximum calorific value (ref. Solas Chapter II-2, Reg 5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation and maintenance.
